

**TOWN OF RED CLIFF, COLORADO
ORDINANCE 1, SERIES 2013**

AN ORDINANCE REPEALING, AMENDING, RESTATING AND RECODIFYING ARTICLES 1 THROUGH 5 OF CHAPTER 13 OF THE TOWN OF RED CLIFF MUNICIPAL CODE BY:

(1) RECODIFYING ARTICLE 1 OF CHAPTER 13 OF THE TOWN OF RED CLIFF MUNICIPAL CODE UNDER THE TITLE WATER ACTIVITY; (2) REPEALING, AMENDING, RESTATING AND RECODIFYING ARTICLE 1 OF CHAPTER 13 OF THE TOWN OF RED CLIFF MUNICIPAL CODE AT PARTS 1, 3 AND 4 OF ARTICLE 1 OF THE TOWN OF RED CLIFF MUNICIPAL CODE; (3) REPEALING, AMENDING, RESTATING AND RECODIFYING ARTICLE 4 OF THE TOWN OF RED CLIFF MUNICIPAL CODE AT PART 2 OF ARTICLE 1 OF THE TOWN OF RED CLIFF MUNICIPAL CODE; (4) REPEALING AMENDING, RESTATING AND RECODIFYING ARTICLE 2 OF CHAPTER 13 OF THE TOWN OF RED CLIFF MUNICIPAL CODE AT PART 5 OF ARTICLE 1 OF THE TOWN OF RED CLIFF MUNICIPAL CODE; (5) REPEALING, RESTATING AND RECODIFYING ARTICLE 3 OF CHAPTER 13 OF THE TOWN OF RED CLIFF MUNICIPAL CODE AT PART 6 OF ARTICLE 1 OF THE TOWN OF RED CLIFF MUNICIPAL CODE; AND (6) REPEALING ARTICLE 5 OF CHAPTER 13 OF THE TOWN OF RED CLIFF MUNICIPAL CODE.

WHEREAS, the Town of Red Cliff is a municipal corporation and body politic organized under the laws of the State of Colorado and possessing the maximum powers, authority and privileges to which it is entitled under Colorado law; and,

WHEREAS, the Town of Red Cliff, by virtue of its status, may adopt ordinances relative to local municipal matters as are necessary to effectuate the purposes and intent of the powers granted to municipalities.

NOW, THEREFORE, THE TOWN OF RED CLIFF ORDAINS:

Section 1: Article 1 of the Town of Red Cliff Municipal Code is renamed Water Activity in the form of the attached Chapter 13 of the Town of Red Cliff Municipal Code, made a part hereof by reference.

Section 2: Article 1 of the Town of Red Cliff Municipal Code is repealed, revised, restated and recodified at Parts 1, 3 and 4 of Article 1 of the Town of Red Cliff Municipal Code in the form of the attached Chapter 13 of the Town of Red Cliff Municipal Code, made a part hereof by reference.

Section 3: Article 4 of the Town of Red Cliff Municipal Code is repealed, revised, restated and recodified at Part 2 of Article 1 of the Town of Red Cliff Municipal Code in the form of the attached Chapter 13 of the Town of Red Cliff Municipal Code, made a part hereof by reference.

Section 4: Article 2 of the Town of Red Cliff Municipal Code is repealed, revised, restated and recodified at Part 5 of Article 1 of the Town of Red Cliff Municipal Code in the form of the attached Chapter 13 of the Town of Red Cliff Municipal Code, made a part hereof by reference.

Section 5: Article 3 of the Town of Red Cliff Municipal Code is repealed, restated and recodified at Part 6 of Article 1 of the Town of Red Cliff Municipal Code in the form of the attached Chapter 13 of the Town of Red Cliff Municipal Code, made a part hereof by reference.

Section 6: Article 5 of the Town of Red Cliff Municipal Code is repealed.

Section 7: Severability. If any section, provision or part of this Ordinance is for any reason held to be unconstitutional or invalid, the remainder of this Ordinance shall continue in full force and effect, it being the legislative intent that this Ordinance would have been adopted even if such unconstitutional or invalid matter had not been included therein. It is further declared that if any section, provision or part of this Ordinance, or the application thereof to any person or circumstance, is held invalid, the remainder of the Ordinance and the application thereof to other persons shall not be affected thereby.

Section 8: Effective Date. This Ordinance shall become effective thirty (30) days after publication thereof.

Section 9: The Board of Trustees hereby finds, determines and declares that this Ordinance is necessary and proper for the health, safety and welfare of the Town of Red Cliff and the inhabitants thereof.






